  1. Provide to the ACC that a suitable completion bond has been made to insure completion of the building and to indemnify Owner against material and mechanic liens.
  2. Copy of a loan that references the owner, dates of the loan, legal description or address of the property, and amount of loan.
  3. An original letter from a financial institution that references the owner, legal description or address of the property, and a statement to the effect the owner has funds available in excess of \$\$\$ for construction. Letter must be signed by financial institution.

- An updated copy of a builder’s risk insurance **policy** in the name of the owner or builder. The policy is to reference the legal description or address of the property, inclusive dates of coverage, and an amount that is equal to the value of the project.
- Has there been any changes to the location, size, and/or any additions to the project?

- If on Septic - Has the septic been installed?
